Guidelines for granting exemption (Professional Certificate in Teaching and Learning in Higher Education)

An exemption will be granted only in exceptional circumstances.

Active or graduated students of the Postgraduate Certificate in Academic Practice (PCAP) offered by TALIC are eligible for exemption. If this applies to you, please apply, indicating your enrolment details in Section C of the exemption form.

Colleagues who have a teaching certificate certifying completion of a course of equivalent standard and duration, or have teaching experience that satisfy the following criteria may also be invited to attend an interview in order for his/her eligibility for exemption to be assessed:

- a) at least 2 years of teaching,
- b) in an English-speaking teaching and learning environment,
- c) full-time (conducted while serving in a full-time capacity, carrying out at least 8 hours of teaching per week),
- d) taught for at least one semester at HKU, or another institution implementing Outcomes-Based Approach to Student Learning (OBASL)
- e) successful (demonstrated by student evaluation results and / or reference), and
- f) recent (within two years of the date of application for exemption).

Please note that an invitation to the interview DOES NOT guarantee that an exemption will be granted.
